### Applying for English test

# Type of work permit

### Employer-specific work permit

An **employer-specific work permit** lets you work in Canada according to the conditions on your work permit, such as

- the name of the specific employer you can work for
- how long you can work
- the location where you can work (if applicable)

Before you apply for an employer-specific work permit, your employer must give you

- a copy of your employment contract
- 1 of the following:
  - a copy of a labour market impact assessment (LMIA)
  - an offer of employment number (for LMIA-exempt workers)
    - To get this number, your employer must use the <u>Employer Portal</u>.



#### **Document: Employment Reference Letter**

#### Document: Education (diplomas/degrees)

### Temporary residents (students, workers, visitors), Express Entry and Canadian citizenship certificate

- The photo must show a full front view of the head and tops of shoulders, with the face in the middle of the photo.
- Size of the head, from chin to crown, must be between 31mm and 36mm.
- Image size: at least 420 x 540 pixels.
- We accept JPEG or JPEG2000 format.
- · File size: approximately 240 kB, no more than 4 MB.
- Image must be in colour (24 bits per pixel) in RGB colour space, the common output for most digital cameras.

### Temporary residents and Express Entry

- The final frame size of the photo must be at least 35mm x 45mm.
- If you scan an existing photo, the minimum resolution must be 600 pixels per inch.

#### Canadian citizenship certificate

- Final frame size of the photo must be 50mm x 70mm.
- Upload a colour digital photo taken by a commercial photographer (We don't accept black and white photos).
- · Scanned photos are not accepted.
- Photo must be taken within the last 6 months.



## Medical Exam Form

- This form is applicable only for certain countries.
- After you fill the application, it will take a few weeks to review.
- If you need a medical exam, you will be provided a UCI and IME number. Schedule an appointment with IRCC registered hospital for the same. They will take a few days to finish the process. They will directly send your medical report to the IRCC.

### REQUEST FOR MEDICAL EXAM

#### DETERMINE IF YOU NEED A MEDICAL EXAM

You will need a medical exam if you:

- have lived or stayed for six or more months in a row in <u>one of these country or territory</u> in the one year before you where you do not need a visa to enter Canada.
- are coming to Canada to work in a job where public health must be protected. See a list of jobs for which you neer
   are applying for a Parent and Grandparent Super Visa.

#### JOBS FOR WHICH YOU NEED A MEDICAL EXAM

Some temporary foreign workers will need to have a medical exam. This depends on the job you plan to do in Cana every possible job.
